# SPEAKER BIOS



## SETH BLOOM

President and Founder  
Bloom Strategic Counsel PLLC

Seth Bloom is the president and founder of Bloom Strategic Counsel PLLC. Mr. Bloom, the former long time general counsel of the US Senate Antitrust Subcommittee, is an attorney with extensive governmental and private sector experience in antitrust and competition law.

Prior to founding Bloom Strategic Counsel in March 2013, Mr. Bloom spent nearly fourteen years working in the US Senate on the Judiciary Committee's Antitrust Subcommittee. He began as a counsel on the Antitrust Subcommittee staff of Senator Kohl in 1999, who served as chairman and ranking member of the Subcommittee during Mr. Bloom's tenure. From 2008 to January 2013, Mr. Bloom served as general counsel of the Senate Antitrust Subcommittee.

Mr. Bloom has also been frequently called on to serve as an expert speaker on critical issues of antitrust, competition, telecom, high tech, and has also been quoted frequently in the press regarding critical antitrust and competition policy issues, including in the *Wall Street Journal*, *Washington Post*, *Reuters*, *FTC Watch*, and National Public Radio.

Prior to beginning his service at the Senate in 1999, Mr. Bloom spent three years as a trial attorney at the Justice Department's Antitrust Division. During his time at the Justice Department, he investigated numerous corporate mergers, and participated in litigation directed at the enforcement of the antitrust laws. Prior to that, Mr. Bloom spent eleven years as an attorney with Washington, DC law firms, practicing in the area of complex commercial litigation. He holds a JD degree from the University of Pennsylvania Law School and a BA *magna cum laude* from the University of Rochester.



## TERRY CALVANI

Based in Freshfields' Washington, DC office, Terry Calvani focuses on civil and criminal investigations by both federal and state authorities. He also handles acquisitions/joint ventures across a broad range of industries and their review by numerous competition agencies. Mr. Calvani has also provided antitrust counseling to a large number of companies and several trade associations.

Prior to joining Freshfields, he was commissioner as well as acting chairman of the US Federal Trade Commission. He was also a member (of the board) of the Irish Competition Authority and director of the Criminal Cartels Division.

Mr. Calvani is the editor of a book and numerous articles on competition law and policy and has lectured extensively on the subject. He has served as chairman of several ABA Antitrust Section committees and two terms on its governing council. He is a member of the American Law Institute, serves on the advisory board of the *Antitrust Bulletin*, and has been a member of the Administrative Conference of the United States. Mr. Calvani is listed as a leading antitrust and regulatory lawyer in many guides and directories and was recently named one of the top 20 antitrust lawyers globally by *Who's Who Legal* published by Law Business Research.

James C. Cooper is associate professor of law and director of the Program on Economics & Privacy at George Mason University School of Law. Prior to joining George Mason, he spent several years at the Federal Trade Commission, most recently as an advisor to Commissioner William Kovacic. Dr. Cooper also worked in the FTC's Office of Policy Planning, where he last served as acting director. Prior to joining the FTC, he was an associate in the antitrust group at Crowell & Moring LLP in Washington, DC.

Dr. Cooper has taught law and economics at Johns Hopkins University, and his research has appeared in publications including the *Antitrust Law Journal*, *International Journal of Industrial Organization*, and the *Boston University Law Review*.

Dr. Cooper has a PhD in economics from Emory University and a JD from George Mason University School of Law, where he was a Levy Fellow.



## DEBORAH L. FEINSTEIN

Director, Bureau of Competition  
Federal Trade Commission

Deborah L. Feinstein was appointed the director of the Federal Trade Commission's Bureau of Competition (BC) by Chairwoman Edith Ramirez on June 17, 2013. She oversees the Commission attorneys, investigators, and administrative personnel working to enforce the antitrust laws for the benefit of consumers.

Ms. Feinstein joined the agency from Arnold & Porter, where she was a partner and chair of the Antitrust Practice Group. She began her career at Arnold & Porter and first joined the FTC in 1989 where she served as an assistant to the BC director and as an attorney advisor to a former Commissioner before returning to private practice.

Among her many accolades, *Global Competition Review* named Ms. Feinstein global "Lawyer of the Year" for 2010. She is a graduate of Harvard Law School (1987) and the University of California at Berkeley (1983).

## DOUGLAS H. GINSBURG

Senior Judge  
United States Court of Appeals for the District of  
Columbia Circuit  
Professor of Law  
George Mason University School of Law

Senior Circuit Judge Douglas Ginsburg was appointed to the US Court of Appeals for the DC Circuit in 1986; he served as Chief Judge from 2001 to 2008. After receiving his BS from Cornell University in 1970, and his JD from The University of Chicago Law School in 1973, he clerked for the Honorable Carl McGowan on the DC Circuit, and for Justice Thurgood Marshall of the US Supreme Court. He was then a professor at the Harvard Law School (1975-1983), deputy assistant and then assistant attorney general in the Antitrust Division of the Department of Justice, and as the administrator of the Office of Information and Regulatory Affairs in the Office of Management and Budget. Judge Ginsburg is also a professor of law at George Mason University School of Law .

Judge Ginsburg serves on the advisory boards of: *Competition Policy International*; the *Harvard Journal of Law and Public Policy*; the *Journal of Competition Law and Economics*; the *Journal of Law, Economics and Policy*; the *Supreme Court Economic Review*; the *University of Chicago Law Review*; and the Law & Economics Center at George Mason University School of Law.



## MEGAN E. JONES

Partner

Megan Jones focuses on recovering damages for corporate victims of antitrust cartels for price-fixing, tying, restraints of trade, and other competition violations. She performs cartel analyses for her corporate clients, surveying purchase records for potential anti-competitive losses. She then makes recommendations about which losses can be recovered. Recoveries from the cases she has been involved in total well over half a billion dollars. She is adept at representing both classes of businesses that were harmed as well as individual businesses.

Ms. Jones has been recognized locally and globally as a leader in the Antitrust and E-Discovery bars. In 2014, independent researchers at *Global Competition Review* and *Who's Who Legal* selected her as one of just three women represented on their list of "The International Who's Who of Competition Lawyers & Economists." In 2013, *Global Competition Review* named her as one of the 100 successful Women in Antitrust globally. She was one of just twenty-three US Lawyers selected for this global honor and the only US lawyer who exclusively focuses her practice on pursuing recovery for victims of cartels.

She is the founder of Women Antitrust Plaintiffs' Attorneys, a national organization dedicated to exchanging best practices and information for women who primarily practice cartel law on behalf of victims. Ms. Jones earned her JD at the University of North Carolina at Chapel Hill School of Law, and her BA (*magna cum laude*) at North Carolina State University.



## WILLIAM E. KOVACIC

Global Competition Professor of Law and Policy,  
Professor of Law, and Director, Competition Law  
Center  
The George Washington University Law School

William E. Kovacic is the Global Competition Professor of Law and Policy, professor of law, and director of the Competition Law Center at The George Washington University Law School.

Before joining the Law School in 1999, Professor Kovacic was George Mason University Foundation Professor at the George Mason University School of Law. From June 2001 to December 2004, he served as the general counsel for the Federal Trade Commission. He is a recognized expert in the fields of antitrust law and government contracts law.

He is co-author (with Andrew Gavil and Jonathan Baker) of *Antitrust Law in Perspective: Cases, Concepts and Problems in Competition Policy* (2002) and is co-author (with Stephen Calkins and Ernest Gellhorn) of *Antitrust Law and Economics in a Nutshell* (5th ed. 2004). Since 1992, Professor Kovacic has served as an adviser on antitrust and consumer protection issues to the governments of Armenia, Benin, Egypt, El Salvador, Georgia, Guyana, Indonesia, Mongolia, Morocco, Nepal, Panama, Russia, Ukraine, Vietnam, and Zimbabwe.

Professor Kovacic earned his BA from Princeton University and his JD from Columbia University Law School.



## THOMAS A. LAMBERT

Wall Chair in Corporate Law and Governance  
and Professor of Law  
University of Missouri School of Law

Thomas A. Lambert is the Wall Chair in Corporate Law and Governance and Professor of Law. Professor Lambert's scholarship focuses on antitrust, corporate and regulatory matters. He is co-author of *Antitrust Law: Interpretation and Implementation* (5th ed., Foundation Press, 2013) and has authored or co-authored more than twenty journal articles in such publications as the *Antitrust Bulletin*, the *Boston College Law Review*, the *Minnesota Law Review*, the *Texas Law Review*, and the *Yale Journal on Regulation*. He blogs regularly at *Truth on the Market*, a site focused on academic commentary on antitrust, business, and economic legal issues.

Professor Lambert has received the law school's Blackwell Sanders Peper Martin Distinguished Faculty Achievement Award for teaching excellence and the university-wide Gold Chalk Award for Excellence in Teaching at the graduate level. In 2007 and 2011, his work was honored with the Shook Hardy & Bacon Excellence in Research Award for best law faculty scholarship.

Before entering academia, he practiced law in the Chicago office of Sidley Austin and was a John M. Olin Fellow at Northwestern University School of Law and the Center for the Study of American Business (now the Murray Weidenbaum Center) at Washington University. After graduating from law school, he clerked for the Honorable Jerry E. Smith of the US Court of Appeals for the Fifth Circuit.

## KRISTEN C. LIMARZI

Chief, Appellate Section, Antitrust Division  
US Department of Justice

Kristen Limarzi became chief of the Appellate Section of the Antitrust Division of the US Department of Justice in October 2013—after working for six years as a staff attorney in the section. In this position, she supervises the section's eight staff attorneys, who represent the Division in all civil and criminal cases in the US courts of appeals. The section, in conjunction with the Solicitor General's Office, also prepares all Division briefs in the US Supreme Court. In addition, its responsibilities include filing briefs and arguing on behalf of the United States as amicus curiae in selected private antitrust cases.

Ms. Limarzi received her law degree from Georgetown University Law Center in 2002. She received her bachelor of arts degree in political science from Swarthmore College in 1997. Following law school, she clerked for the Honorable Leonie M. Brinkema in the US District Court for the Eastern District of Virginia. From 2003 to 2007, she worked for King & Spalding LLP in Washington, DC, and joined the Antitrust Division's Appellate Section in 2008 as a staff attorney.



## ABBOTT B. LIPSKY JR.

Partner  
Latham & Watkins LLP

Tad Lipsky is a partner in the Washington, DC office of Latham & Watkins LLP. He is an internationally recognized expert on antitrust and competition law and policy and a veteran of numerous antitrust proceedings in scores of jurisdictions throughout the world. He served as deputy assistant attorney general under William F. Baxter, playing central roles in preparation of the 1982 Justice Department Merger Guidelines, the review and ultimate dismissal of *United States v. IBM Corp.*, the amicus program that resulted in profound changes in Supreme Court interpretation of antitrust law, and the decisive realignment of the interface between antitrust enforcement policy and intellectual property law that occurred in the first Reagan Administration. After nine years of private practice in Washington DC, he was appointed chief global antitrust lawyer for The Coca-Cola Company in 1992.

After joining Latham & Watkins in 2002, he served as the inaugural international officer of the ABA Section of Antitrust Law and since then has been closely associated with efforts to streamline antitrust enforcement around the world, advocating the reduction of compliance burdens and the harmonization of fundamental objectives of antitrust law.



## GEOFFREY A. MANNE

Founder and Executive Director  
International Center for Law and Economics

Geoffrey A. Manne is the founder and executive director of the International Center for Law and Economics (ICLE), based in Portland, Oregon. In 2015 he was also appointed to the FCC's Consumer Advisory Commission, where he co-chairs the Broadband Working Group. He is an expert in the economic analysis of law, drawing on two degrees from the University of Chicago. He specializes in antitrust, telecommunications, consumer protection, intellectual property, and technology policy. His publications have appeared in numerous journals including the *Journal of Competition Law and Economics*, the *Harvard Journal of Law and Public Policy*, the *Supreme Court Economic Review*, and the *Columbia Business Law Review*. With former FTC Commissioner Joshua Wright, Professor Manne is the editor of a volume from Cambridge University Press entitled *Competition Policy and Intellectual Property Law Under Uncertainty: Regulating Innovation*.

Prior to founding ICLE, Professor Manne was a law professor at Lewis & Clark Law School. From 2006-2009, he took a leave from teaching to develop Microsoft's legal and economics academic outreach program. He has also served as a lecturer in law at the University of Chicago Law School and the University of Virginia School of Law. He practiced antitrust law and appellate litigation at Latham & Watkins, clerked for the Honorable Morris S. Arnold on the 8th Circuit Court of Appeals, and worked as a research assistant for Judge Richard Posner. He was also once (very briefly) employed by the FTC.



## FRANK MONTAG

Frank Montag is an antitrust, competition, and trade partner in Freshfields' Brussels office. From 2000 to 2006, he co-chaired the firm's global antitrust group, and is currently chair of the firm's Finance and Risk Committee.

He is chairman of the Studienvereinigung Kartellrecht (the Antitrust Lawyers' Association for Germany, Austria and Switzerland) and has been a non-governmental adviser to the International Competition Network (ICN) since 2001. He serves on the advisory council of the Max Planck Institute for Intellectual Property and Competition Law, Munich.

Dr. Montag is co-editor of *Competition Law: European Community Practice and Procedure* (Sweet & Maxwell) and of *MünchKer Kommentar zum Wettbewerbsrecht* (Beck). Dr. Montag has been named Global Competition Lawyer of the Year for six years running at the *Global Competition Review's* Who's Who Legal Awards.

## DANIEL P. O'BRIEN

Senior Economic Advisor  
Federal Trade Commission

Daniel O'Brien is senior economic advisor in the Applied Research and Outreach Division of the Federal Trade Commission. He has served in this position since 2007. His fields of interest include microeconomics, industrial organization, antitrust, regulation, game theory, and applied econometrics.

Mr. O'Brien also served the FTC as the deputy director for Antitrust in the Bureau of Economics from 2000 to 2002. He was also the chief of the Economic Regulatory Section, Antitrust Division, of the US Department of Justice from 2005 to 2007.

In addition to his government service, Mr. O'Brien has been a visiting professor of economics at the Kelley School of Business at Indiana University from 2014 to 2015 and an assistant professor of economics at the University of Michigan from 1989 to 1992.

Mr. O'Brien earned his PhD and MA in economics from Northwestern University and his BA in economics from Carleton College.



## MAUREEN K. OHLHAUSEN

Maureen K. Ohlhausen was sworn in as a Commissioner of the Federal Trade Commission on April 4, 2012, to a term that expires in September 2018.

Prior to joining the Commission, Commissioner Ohlhausen was a partner at Wilkinson Barker Knauer LLP, where she focused on FTC issues, including privacy, data protection, and cybersecurity.

Commissioner Ohlhausen previously served at the Commission for eleven years, most recently as director of the Office of Policy Planning from 2004 to 2008, where she led the FTC's Internet Access Task Force. She was also deputy director of that office. From 1998 to 2001, Commissioner Ohlhausen was an attorney advisor for former FTC Commissioner Orson Swindle. She started at the FTC General Counsel's Office in 1997.

Before coming to the FTC, Commissioner Ohlhausen spent five years at the US Court of Appeals for the DC Circuit, serving as a law clerk for the Honorable David B. Sentelle and as a staff attorney. Commissioner Ohlhausen also clerked for the Honorable Robert Yock of the US Court of Federal Claims from 1991 to 1992.

Commissioner Ohlhausen graduated with distinction from George Mason University School of Law in 1991 and graduated with honors from the University of Virginia in 1984.



## JEANNE PRATT

Jeanne Pratt was appointed to the position of senior deputy commissioner of the Mergers Branch of the Government of Canada's Competition Bureau effective January 16, 2015. Ms. Pratt first joined the Bureau in 2009 as special legal advisor to the Commissioner where she provided strategic input on a range of issues, including the conduct of litigation. In 2011, she was appointed to the position of assistant deputy commissioner, Division B, of the Criminal Matters Branch. She most recently served in the position of associate deputy commissioner, Criminal Matters Branch.
