### **SANJAI BHAGAT**

Provost Professor of Finance University of Colorado, Boulder

Whether advising Fortune 500 companies or using his work experience at the US Securities Exchange Commission to illustrate a point in class, Professor Sanjai Bhagat is easily able to explain complicated financial theories to students. Throughout his more than 20-year teaching career, Bhagat has been recognized for excellence in education. He was the Graduate Professor of the Year and winner of the Frascona Undergraduate Teaching Excellence Award and an Educator of Distinction Award Finalist. In addition to teaching finance at the Leeds School of Business, Bhagat is also connected to the start-up community in Colorado and is the founding director of TiE-Rockies (The Indus Entrepreneurs) - a professional group for technology entrepreneurs. His paper, "Corporate Governance and Corporate Performance," was awarded the Paper of the Decade Award for being the most impactful paper in the Journal of Corporate Finance during 2008-2018. His work, "The Promise and Perils of Corporate Governance Indices," was selected as one of the "Best Corporate and Securities Articles" by the Vanderbilt Law School Publication Corporate Practice Commentator. The European Corporate Governance Institute also awarded the article the De Brauw Blackstone Westbroek Law Prize for best paper.

Josh Blackman is a national thought leader on constitutional law and the United States Supreme Court. Josh's work was quoted during two presidential impeachment trials. He has testified before Congress and advises federal and state lawmakers. Josh regularly appears on TV, including NBC, CBS, ABC, Fox, and the BBC. Josh is also a frequent guest on NPR and other syndicated radio programs. He has published commentaries in the *New York Times, Wall Street Journal, Washington Post*, and leading national publications.

Since 2012, Josh has served as a professor at the South Texas College of Law Houston. Josh is also an adjunct scholar at the Cato Institute. Josh has authored three books. His latest, *An Introduction to Constitutional Law*, was a top-five bestseller on Amazon. Josh has written more than five dozen law review articles that have been cited nearly a thousand times. Josh was selected by *Forbes Magazine* for the "30 Under 30" in Law and Policy. Josh is the president of the Harlan Institute, and founded FantasySCOTUS, the Internet's premier Supreme Court Fantasy League.

Professor Donald J. Boudreaux was the chairman of the Department of Economics at George Mason University in Fairfax, Virginia, from August 2001 to August 2009. Previously, he was the director of the Center for the Study of Public Choice, president of the Foundation for Economic Education from 1997 to 2001, associate professor of legal studies and economics at Clemson University from 1992 to 1997, and assistant professor of economics at George Mason University from 1985 to 1989. During the spring 1996 semester, he was an Olin Visiting Fellow in Law and Economics at Cornell Law School. His PhD in economics is from Auburn University, and his JD is from the University of Virginia. Professor Boudreaux has lectured nationally and internationally on various topics, including the nature of law, antitrust law and economics, and international trade. He is published in *The Wall Street Journal, Investor's Business Daily, Regulation, Reason, Ideas on Liberty, The Washington Times, The Journal of Commerce,* the Cato Journal, and several prominent scholarly journals. He is the author of *Globalization* (Greenwood Press, 2008) and co-authors the blog Cafe Hayek.

### **GAIL HERIOT**

Professor of Law University of San Diego School of Law

Gail Heriot is a Professor of Law at the University of San Diego. Among her areas of expertise are civil rights, employment law, product liability, remedies, and torts. Her work has appeared in legal journals like the *Michigan Law Review*, the *Virginia Law Review*, and the *Harvard Journal on Legislation*. She also frequently writes for popular newspapers and magazines, including the *Wall Street Journal*, the *National Review*, the *Los Angeles Times*, and the *San Diego Union Tribune*. She is the editor and an author of a forthcoming anthology of essays entitled, "California Dreaming: Race, Gender, Proposition 209 and the Principle of Non-Discrimination."

Professor Heriot is a former civil rights counsel to the US Senate Committee on the Judiciary and a former Associate Dean for Academic Affairs at George Mason University Law School. She has also served on several boards and is currently a member of the Board of Directors of the National Association of Scholar. Prior to entering academia, she practiced law at the Washington law firm of Hogan & Hartson and the Chicago law firm of Mayer, Brown, & Platt. She clerked for the Honorable Seymour F. Simon of the Illinois Supreme Court. Professor Heriot graduated with the highest distinction from Northwestern University in 1978 and earned her JD cum laude in 1981 from the University of Chicago Law School, where she served as an associate editor of the law review. She is a member of Phi Beta Kappa and the Order of Coif.

Professor of Law

Professor Kochan's scholarship focuses on the areas of property law, constitutional law, administrative law, natural resources and environmental law, tort law, and law and economics. He has published more than 40 scholarly articles and essays in well-regarded law journals, and his work is cited in dozens of books and hundreds of published law review articles. Professor Kochan is an elected member of the American Law Institute (ALI); and ALI appointed him in July 2016 to serve as an adviser to the Restatement of the Law Fourth, Property project. John O. McGinnis is a graduate of Harvard College and Harvard Law School where he was an editor of the *Harvard Law Review*. He also has an MA degree from Balliol College, Oxford, in philosophy and theology. Professor McGinnis clerked on the US Court of Appeals for the District of Columbia. From 1987 to 1991, he was deputy assistant attorney general in the Office of Legal Counsel at the Department of Justice. ## SABRINA S. MCKENNA

Sabrina McKenna became a justice of the Hawai'i Supreme Court in 2011. She graduated from the University of Hawai'i at Manoa ("UHM") and UHM's William S. Richardson School of Law ("WSRSL"), where she served as Editor-in-Chief of the Law Review. She practiced civil litigation and business law at the Honolulu firm of Goodsill Anderson Quinn & Stifel, then served as corporate secretary and general counsel to Japan-based Otaka, Inc., as an instructor in Business Law at the UHM Shidler College of Business, and as an assistant professor at the WSRSL. In 1993, she was appointed to Hawaii's limited jurisdiction District Court. From her 1995 appointment to the general jurisdiction Circuit Court until 2011, she presided over civil, criminal, and family law cases, also serving as presiding judge of the Family Court of the First Circuit of Oahu. She serves on the Law & Economics Center's Judicial Advisory Board.

Dean Erin O'Hara O'Connor is a noted scholar in several areas, including conflict of laws, arbitration, and the law market. George Priest is the Edward J. Phelps Professor of Law and Economics at Yale Law School. He has recently published a book *The Rise of Law and Economics: An Intellectual History*, which has been featured at LEC Conferences for Judges. ### **LORI S. ROWE**

Chief Judge First Judicial District Court of Appeal, Florida

Judge Lori Rowe was appointed to the Florida First District Court of Appeal in 2009. Before her appointment, she practiced law for 12 years. She spent four years in the Office of the Attorney General of Florida, where she practiced exclusively in the area of antitrust law. She joined the Gray Robinson law firm in 2000, where her practice areas included commercial litigation, antitrust and appellate law. In 2002, Judge Rowe returned to the Office of the Attorney General where she served as Director of Multistate Litigation and later as Executive Deputy Attorney General, advising the Attorney General on multistate investigations and complex litigation. In 2007, she joined the Executive Office of the Governor as Deputy Chief of Staff. She served as the Governor's chief policy advisor on a wide variety of issues affecting Florida's criminal justice and health and human services agencies.
