How well was the evidence used? A few examples

2011 DCL on sexual violence, p. 2:

"A report prepared for the National institute of Justice found that about 1 in 5 women are victims of completed or attempted sexual violence while in college."

*Christopher P. Krebs et al, The Campus Sexual Assault Study: Final Report"

Christopher P. Krebs and Christine Linguist, lead authors of that study, 2014:

"The 1-in-5 statistic is *not* a representative estimate of the prevalence of sexual assault, and we have never presented it as being representative of anything other than the population of senior undergraduate women at the two universities where data was collected—two large public universities, one in the South and one in the Midwest."

2014 DCL on equitable distribution of school resources, p. 3

"For example, participation in high-quality arts programs, including music and visual arts, is valuable to all students.*"

2014 DCL on addressing racial disparities in school discipline

Central claim = disparities in discipline are the result of discriminatory policies and use of discretion

Studies did control for poverty levels, but did not control for—

- Number of past infractions

- Differences among schools
 Growing up in single-parent family
 Living in high-crime neighborhoods
 Abuse and neglect within family
